A local law FIXING THE ANNUAL SALARY OF THE HAMILTON COUNTY COMMISSIONER OF SOCIAL SERVICES. (insert title)

Be it enacted by the BOARD OF SUPERVISORS of the (Name of Legislative Body)

Legislative Intent: The Hamilton County Social Services Commissioner's annual salary for the year 1987 was set by resolution at Nineteen Thousand Dollars (\$19,000.00). That to bring the Hamilton County Social Services Commissioner's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Social Services Commissioner for the year 1987 will be Twenty Thousand Dollars (\$20,000.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Social Services Commissioner's annual salary for the year 1987 at Twenty Thousand Dollars (\$20,000.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
