Local Law No. 2 of the year 19 90

Legislative Intent: The Hamilton County Personnel Director's annual salary for the year 1989 was set by the Hamilton County Board of Supervisors at Fourteen Thousand Eight Hundred Forty Dollars (\$14,840.00). That to bring the Hamilton County Personnel Director's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Personnel Director for the year 1990 will be Sixteen Thousand Three Hundred Twenty Five Dollars (\$16,325.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Personnel Director's annual salary for the year 1990 at Sixteen Thousand Three Hundred Twenty-Five Thousand Dollars (\$16,325.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
