Local Law No. 6 of the year 1990

A local law fixing the annual salary of the Hamilton County Highway Superintendent

Be it enacted by the Board of Supervisors of the

Legislative Intent: The Hamilton County Highway Superintendent's annual salary for the year 1989 was set by the Hamilton County Board of Supervisors at Twenty-Six Thousand Five Hundred Dollars (\$26,500.00). That to bring the Hamilton County Highway Superintendent's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Highway Superintendent for the year 1990 will be Thirty Thousand Dollars (\$30,000.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Highway Superintendent's annual salary for the year 1990 at Thirty Thousand Dollars (\$30,000.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
