Legislative Intent: The Hamilton County Director of Real Property Tax Service's annual salary for the year 1990 was set by the Hamilton County Board of Supervisors at Twenty Five Thousand Dollars (\$25,000.00). That to bring the Hamilton County Director of Real Property Tax Service's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Director of Real Property Tax Service for the year 1991 will be Twenty-Six Thousand Two Hundred Fifty Dollars (\$26,250.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Director of Real Property Tax Service's annual salary for the year 1991 at Twenty-Six Thousand Two Hundred Fifty Dollars (\$26,250.00)

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as
