Local Law No. 4 of the year 19 .. 91

A local law Fixing the Annual Salary of the Hamilton County Treasurer

Be it enacted by the Board of Supervisors of the

Legislative Intent: The Hamilton County Treasurer's annual salary for the year 1990 was set by the Hamilton County Board of Supervisors at Twenty-Nine Thousand Two Hundred Dollars (\$29,200.00). That to bring the Hamilton County Treasurer's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Treasurer for the year 1991 will be Thirty Thousand Six Hundred Sixty Dollars (\$30,660.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Treasurer's annual salary for the year 1991 at Thirty Thousand Six Hundred Sixty Dollars (\$30,660.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
