Legislative Intent: The Hamilton County Commissioner of Social Services' annual salary for the year 1991 was set by the Hamilton County Board of Supervisors at Thirty-Four Thousand Six Hundred Fifty Dollars (\$34,650.00). That to bring the Hamilton County Commissioner of Social Services' annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Commissioner of Social Services for the year 1992 will be Thirty Six Thousand Three Hundred Eighty Five Dollars (\$36,385.00).

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Commissioner of Social Services' annual salary for the year 1992 at Thirty Six Thousand Three Hundred Eighty Five Dollars (\$36,385.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
