A local law Fixing the Annual Salary of the Hamilton County Highway

Be it enacted by the Board of Supervisors of the

Legislative Intent: The Hamilton County Highway Superintendent's annual salary for the year 1991 was set by the Hamilton County Board of Supervisors at Thirty-One Thousand Five Hundred Dollars (\$31,500.00). That to bring the Hamilton County Highway Superintendent's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Highway Superintendent for the year 1992 will be Thirty-Three Thousand Seventy Five Dollars (\$33,075.00).

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Highway Superintendent's annual salary for the year 1992 at Thirty Three Thousand Seventy Five Dollars (\$33,075.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
