A local law Fixing the Annual Salaries of the Hamilton County Republican
(Insert Title) and Democrat Commissioners of Elections

Be it enacted by the Board of Supervisors of the

Legislative Intent: The Hamilton County Republican and Democrat Commissioners of Elections' annual salaries for the year 1991 was set by the Hamilton County Board of Supervisors at Fifteen Thousand Five Hundred Dollars (\$15,500.00) for each Commissioner. That to bring the Hamilton County Republican and Democrat Commissioners of Election's annual salaries into conformity with the other appointed officials, the annual salaries for the Hamilton County Republican and Democrat Commissioners of Elections for the year 1992 will be Seventeen Thousand Five Hundred Dollars (\$17,500.00) for each Commissioner.

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Republican and Democrat Commissioners of Elections' annual salaries for the year 1992 at Seventeen Thousand Five Hundred Dollars (\$17,500.00) for each Commissioner.

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
