Legislative Intent: The Hamilton County Sheriff's annual salary for the year 1992 was set by the Hamilton County Board of Supervisors at Thirty Three Thousand Six Hundred Dollars (\$33,600.00). That to bring the Hamilton County Sheriff's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Sheriff for the year 1993 will be Thirty Four Thousand Six Hundred Eight Dollars (\$34,608.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Sheriff's annual salary for the year 1993 at Thirty Four Thousand Six Hundred Eight Dollars (\$34,608.00).
2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
