Local Law No. 2 of the year 1994

A local law fixing the annual salary of the Hamilton County Personnel Officer

Legislative Intent: The Hamilton County Personnel Officer's annual salary for the year 1993 was set by the Hamilton County Board of Supervisors at Eighteen Thousand Twenty Five Dollars (\$18,025.00). That to bring the Hamilton County Personnel Officer's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Personnel Officer for the year 1994 will be Twenty One Thousand One Hundred Twenty Six Dollars (\$21,126.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Personnel Officer's annual salary for the year 1994 at Twenty One Thousand One Hundred Twenty Six Dollars (\$21,126.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
