Local Law No. 4 of the year 19 95

A local law fixing the annual salary of the Hamilton County Treasurer

Legislative Intent: The Hamilton County Treasurer's annual salary for the year 1994 was set by the Hamilton County Board of Supervisors at Thirty Four Thousand One Hundred Sixty One Dollars (\$34,161.00). That to bring the Hamilton County Treasurer's annual salary into conformity with the other appointed officials, the annual salary for the Hamilton County Treasurer for the year 1995 will be Thirty Five Thousand One Hundred Eighty Six Dollars (\$35,186.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Treasurer's annual salary for the year 1995 at Thirty Five Thousand One Hundred Eighty Six Dollars (\$35,186.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
