A local law fixing the annual salaries of the Hamilton County Commissioners of

Legislative Intent: The Hamilton County Republican and Democrat Commissioners of Election annual salaries for the year 1995 was set by the Hamilton County Board of Supervisors at Nineteen Thousand Four Hundred Ninety Four Dollars (\$19,494.00). That to bring the Hamilton County Republican and Democrat Election Commissioners' annual salaries into conformity with the other appointed officials, the annual salary for the Hamilton County Republican and Democrat Commissioners of Election for the year 1996 will be Twenty Thousand Two Hundred Thirty Three Dollars (\$20,233.00) for each Commissioner.

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Republican and Democrat Elections Commissioners' annual salaries for the year 1996 at Twenty Thousand Two Hundred Thirty Three Dollars (\$20,233.00) for each Commissioner.

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty-five days (45) after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
