A local law fixing the annual salary of the Hamilton County Attorney and the Attorney

Legislative Intent: The Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries for the year 1996 was set by the Hamilton County Board of Supervisors at Twenty Four Thousand Fifty Three Dollars (\$24,053.00) each. That to bring the Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries into conformity with the other appointed officials, the annual salaries for the Hamilton County Attorney and the Attorney for the Department of Social Services for the year 1997 will be Twenty Four Thousand Five Hundred Thirty Four Dollars (\$24,534.00) each.

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries for the year 1997 at Twenty Four Thousand Five Hundred Thirty Four Dollars (\$24,534.00).
2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
3. This local law is subject to a referendum on petition and shall take effect forty five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required.
