Legislative Intent: The Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries for the year 1998 was set by the Hamilton County Board of Supervisors at Twenty Five Thousand Twenty Fifty Dollars (\$25,025.00) each. That to bring the Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries into conformity with the other appointed officials, the annual salaries for the Hamilton County Attorney and the Attorney for the Department of Social Services for the year 1999 will be Twenty Six Thousand Two Hundred Seventy Five Dollars (\$26,275.00) each.

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Attorney's and the Attorney for the Department of Social Services' annual salaries for the year 1999 at Twenty Six Thousand Two Hundred Seventy Five Dollars (\$26,275.00) each.
2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
3. This local law is subject to a referendum on petition and shall take effect forty five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required.
