A local law fixing the Annual Salaries of the Hamilton County Commissioners, Board

Legislative Intent: The Hamilton County Commissioners, Board of Elections annual salaries for the year 1999 was set by the Hamilton County Board of Supervisors at Twenty Two Thousand Four Hundred Forty Dollars (\$22,440.00). That to bring the Hamilton County Commissioners, Board of Elections annual salaries into conformity with the other appointed officials, the annual salary for the Hamilton County Commissioners, Board of Elections for the year 2000 will be Twenty Two Thousand Eight Hundred Eight Nine Dollars (\$22,889.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Commissioners, Board of Elections annual salaries for the year 2000 at Twenty Two Thousand Eight Hundred Eight Nine Dollars (\$22,889.00).
2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
3. This local law is subject to a referendum on petition and shall take effect forty five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required.




