Legislative Intent: The Hamilton County District Attorney's annual salary for the year 2001 was set by the Hamilton County Board of Supervisors at Forty Four Thousand Eight Hundred Eighty Dollars (\$44,880.00). That to bring the Hamilton County District Attorney's annual salary into conformity with the other appointed and elected officials, the annual salary for the Hamilton County District Attorney for the year 2002 will be Forty Seven Thousand Two Hundred Fourteen Dollars (\$47,214.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County District Attorney's annual salary for the year 2002 at Forty Seven Thousand Two Hundred Fourteen Dollars (\$47,214.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
