Legislative Intent: The Hamilton County Commissioners of the Board of

Elections annual salaries for the year 2001 were set by the Hamilton County Board of Supervisors at Twenty Four Thousand Four Hundred Ninety One Dollars (\$24,491.00) each. That to bring the Hamilton County Commissioners of the Board of Elections annual salaries into conformity with the other appointed and elected officials, the annual salary of each of the Hamilton County Commissioners of the Board of Elections for the year 2002 will be Twenty Five Thousand Seven Hundred Sixty Five Dollars (\$25,765.00).

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

1. That the Hamilton County Board of Supervisors hereby fixes the annual salaries of each of the Hamilton County Commissioners of the Board of Elections for the year 2002 at Twenty Five Thousand Seven Hundred Sixty Five Dollars (\$25,765.00).

2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.

3. This local law is subject to a referendum on petition and shall take effect forty five (45) days after its adoption unless a petition protesting against such local law is filed with the Clerk and signed by qualified electors as required by law.
