A local law FIXING THE ANNUAL SALARY OF THE HAMILTON COUNTY TREASURER

BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

- 1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Treasurer's annual salary for the year 2007 at Fifty-six Thousand Five Hundred Eighteen Dollars (\$56,518.00).
2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
3. This local law is subject to a referendum on petition and shall take effect forty-five (45) days after its adoption unless a petition protesting against such local law is filled with the Clerk and signed by qualified electors as required by law.




