- BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:
1. That the Hamilton County Board of Supervisors hereby fixes the Hamilton County Commissioners of the Board of Elections annual salary for the year 2011 at Forty Thousand Four Hundred Thirty-one Dollars (\$40,431.00).
 2. Insofar as the provisions of this local law are inconsistent with the provisions of other local laws or acts, the provisions of this local law shall be controlling.
 3. This local law is subject to a referendum on petition and shall take effects forty-five (45) days after its adoption unless a petition protesting against such law is filed with the Clerk and signed by qualified electors as required by law.


