Public Comment: No one present.

Reports of Standing/Special Committees:

Mr. Farber: Stated that he had discussed the two resolutions on the agenda for the Emergency Preparedness Committee when they were upstairs. They had a Lake Champlain Lake George Regional Planning Board (LCLGRPB) meeting and part of the outcome for that was the LCLGRPB authorizing Beth Gilles, Director of LCLGRPB, to move forward in getting the CostQuest data for broadband. That is data that is being used universally across the country. They are a vendor that both the State and Federal Communications Commission (FCC) are using. So, by virtue of Ms. Gilles being able to get that data they will have access to more data layers. She expects that they should be prepared by early August to then have meetings between the communities and the providers based on utilizing that data. That will give them the ability to sit down with providers like Spectrum or SLIC and figure out where the gaps still are. One of the big

challenges for them, even with that data in place, will remain the situation around Frontier. Frontier was awarded the early version of broadband funding that came directly from the federal government. Unfortunately for those projects they were very liberal in that they allowed the providers 10 years to do the build out, it is really blocking access to other funds for those areas. The conversation at the regional level and with the ConnectALL Office was started to focus on how to get Frontier to be a good partner in these planning conversations about what the communities need. The County has some corners where there is probably not going to be alternative providers, where they are going to have to partner with Frontier if it's going to be anything other than satellite, but they also have communities (Benson, Hope and Inlet) that could be served very well by Spectrum and (Indian Lake, Long Lake, Lake Pleasant and Wells) by SLIC. Particularly, if they can get DANC funding to build from Indian Lake down to Speculator. They were just awarded the National Telecommunications and Information Administration (NTIA) Award coupled with them working with National Grid that will build fiber from Blue Mountain all the way out the 28 corridor into Warren County and through North Creek. So, the only gap will then be from Indian Lake down to Speculator and that will allow them to link into SLIC's fiber. Then they are going to be building for the County (emergency communications) from the Lake Pleasant Courthouse out to connect to Newport Telephone Company. Even though Frontier hasn't moved to create redundancy they will have a redundant loop all the way through so they can channel singly in both ways to the degree they can get SLIC and others to jump on to use that fiber for backhaul as well as the cellular companies. This will give the County redundancy when the Frontier system goes down.

Mr. Tomlinson: Stated that there are a few Public Works resolutions on the agenda to purchase vehicles as well as a one-year contract with Constellation for electricity.

Mr. Arsenault: Thanked everyone for reaching out during the flood and a huge thank you to Tracy Eldridge, Highway Superintendent, and staff. He stated that the Town, County and State Highway Departments all worked together seamlessly.

RESOLVED, that upon approval of Homeland Security and the County Attorney, the Chairman be authorized to sign a 45 day contract extension with RS Telecom to continue providing service under the same terms and conditions, and that the Emergency Services Director be so notified.

WHEREAS, Hamilton County is in the process of permitting an Emergency Communications Tower in the Town of Hope, and

WHEREAS, there is no viable microwave path currently available to the Hope Tower site, and

WHEREAS, Frontier is the only provider that has Fiber directly from Lake Pleasant to Hope, now, therefore, be it
