Many years later his father kind of regretted it. He stated that he would have liked to have gone to war and his mother reprimanded him at that point. Mr. Hosley wanted to tell that story showing the intermix of their families was nearly a century old. He told Mr. Farber that he had done a fine job and that his heirs would depend on what he built. He thanked him for his service.

Mr. Farber thanked him along with everyone else. He stated that it was simply a labor of love. There is no other way to describe it.

# A LOCAL LAW TO PROVIDE INCREASES IN THE COMPENSATION OF CERTAIN COUNTY OFFICERS

### BE IT ENACTED, by the Hamilton County Board of Supervisors as follows:

SECTION 1. As per Section 201 of County Law, the Board of Supervisors can only increase the salary of a county officer who is elected for a fixed term or appointed for a fixed term, in the middle of that term of office, if Section 24 (2)(h) of the Municipal Home Rule Law is complied with. In keeping with that compliance, Local Law No. 1 of 2024 is hereby enacted setting the annual salaries for the year 2024 for the following county officers who are elected or appointed for a fixed term, and whose terms did not expire on December 31, 2023.

These salaries shall be effective as of January 1, 2024.

SECTION 2. This Local Law shall take effect forty-five (45) days from the date of adoption by the Board of Supervisors unless a petition is filed in accordance with Municipal Home Rule law, and after filing with the Secretary of State. All Department Head salary changes will be implemented uniformly after such filing.

Mr. Farber asked if he could move Resolution No. 28 Adoption of Updates to Hamilton County Employee Handbook. It is not on the agenda. They finalized the language in it late and he apologized for that. He thinks that it now captures what they intended and what they discussed with the Sheriff. They are eligible as early as 41 years old. The County Board concluded they don't want to be fully responsible for health insurance from 41 years old on in the same way they are when somebody retires at 55 or 62 years old. So, this provides an incremental increase in benefits. Not only does that save the County money but it also encourages people to work longer if they are able to. Hopefully it strikes the right balance. With Correction Officers there can be difficulty getting to 62 years old, so it lets them leave at 55 years old but one cautionary note that the County is going to need to be consistent in is reminding those Correction Officers that sometimes they are going to take a hit on their state retirement leaving early. They put that language in there specifically so it would be in the handbook and encourages them to talk to state retirement. Lastly, this addresses the issue of where the Sheriff has been successful in working with other outside agencies to bring in transferees that are already working in law enforcement. It saves the County a significant amount of training cost and lets them hit the ground running. He's hoping that this is one more recruiting tool. It simply allows them into the health insurance even if they haven't got the full 20 years that they now require of county employment. Starting at 10 and prorating up through so that they gain the longer they stay with the County, but it does give them a safety net if they are at a point where they need to retire after 20 years. They get a

significantly reduced health insurance benefit with a much bigger contribution from them, but it does make sure that the County is there for them if they should need it. Mr. Arsenault stated that as chair of the Internal Management Committee he thinks that Mr. Farber changed the verbiage in the resolution to make sense. It clearly dictates what the County is doing. He cleaned it up well and they met with Ms. Ruiz because the Personnel Officer was not available, and it made sense to her as well.

# 808 Medical Insurance for Retirees

**Coverage** – The County currently provides medical insurance coverage to an eligible fulltime employee or elected official who retires from the County. Coverage is also currently available for eligible dependents (including spouse) if they were covered under the County's medical insurance plan at the employee's date of retirement. In the event the retiree predeceases the dependents, the dependents may continue medical insurance coverage provided they pay the full cost of the premium. Coverage of a dependent at the time of divorce or legal separation is in accordance with plan documents and COBRA requirements.

# Hired prior to January 1, 2010

**Eligibility** – To be eligible for coverage, a Hamilton County employee, including elected and appointed officials, must meet each of these requirements: a) have at least ten (10) years of continuous service with the County; b) entitled to receive a retirement benefit from the New York State Retirement System; c) employment was not terminated for cause; d) did not voluntarily terminate his or her employment with Hamilton County prior to obtaining 55 years of age as fixed by the New York State Retirement System. Termination of employment caused by failing to be re-elected or re-appointed shall not be considered as a voluntary termination from county employment nor one for cause. Failing to be reelected shall also include the official who chooses not to run for the elected position. Such elected or appointed official shall be entitled to the foregoing benefits upon obtaining the earliest age of retirement (now 55 years of age) as allowed by the New York State Retirement System, whether or not actually receiving such retirement benefits.

**Premium Payment** (Hired Prior to January 1, 2010) – The County will pay 100% of the premium for individual, two-person or family medical insurance coverage, as the case may be, for each retiree.

Eligibility – Special Sheriff's Retirement Plan (Sheriff, Under Sheriff, Deputy

**Sheriffs**) – To be eligible for coverage, each of the following requirements must be met: a) entitled to retire under the New York State Special Sheriff' Retirement Plan; b) have at least twenty (20) years of continuous service with the County; c) retire directly into New York State Retirement System; d) employment was not terminated for cause; If a), b), c), and d) criteria are met but the retiree has not reached age 55, they would be eligible under the following criteria:

- At forty-one (41) years of age, the retiree is eligible for individual coverage at the same contribution percentage (%) the employee was paying prior to retirement. For a two-person or family coverage, the difference in premium from a single plan, is entirely the responsibility of retiree.
- 2. At fifty (50) years of age, the retire is eligible for two-person or family coverage at the same contribution percentage (%) the employee was paying prior to retirement.
- At fifty-five (55) years of age, the retiree's benefits follow the standard benefit for the Non-Special Sheriff's Retirement Plan available to other Retirees who began County employment prior to January 1, 2010.

# Hired effective January 1, 2010 or Later

**Eligibility** – To be eligible for coverage, a Hamilton County employee, including elected and appointed officials, must meet each of these requirements: a) have at least twenty (20) years of continuous service with the County; b) retire directly from the County into the New York State Retirement System; c) employment was not terminated for cause; d) did not voluntarily terminate his or her employment with Hamilton County prior to obtaining 62 years of age as fixed by the New York State Retirement System. Termination of employment caused by failing to be re-elected or re-appointed shall not be considered as a voluntary termination from County employment nor one for cause. Failing to be re-elected shall also include the official who chooses not to run for the elected position. Such elected or appointed official shall be entitled to the foregoing benefits upon obtaining the earliest age of retirement (now 62 years of age) as allowed by the New York State Retirement System

**Premium Payment** (Hired effective January 1, 2010 or Later) – The Retiree will continue to pay the % of the premium they were contributing as an employee for individual, two-person or family medical insurance coverage, as the case may be.

## Eligibility – Special Sheriff's Retirement Plan (Sheriff, Under Sheriff, Deputy

**Sheriffs**) – To be eligible for coverage, each of the following requirements must be met: a) entitled to retire under the New York State Special Sheriff' Retirement Plan; b) have at least twenty (20) years of continuous service with the County; c) retire directly into New York State Retirement System; d) employment was not terminated for cause; If a), b), c), and d) criteria are met but the retiree has not reached age 55, they would be eligible under the following criteria:

- At forty-one (41) to fifty-four (54) years of age, the retiree is eligible for individual coverage at the same contribution percentage (%) the employee was paying prior to retirement. For a two-person or family coverage, the difference in premium from a single plan, is entirely the responsibility of retiree.
- **2.)** At fifty-five (55) years of age, the retiree's eligibility follows the standard eligibility for the

Non-Special Sheriff's Retirement Plan above.

**Special Sheriff's Retirement Plan for Transfer Hires** – To meet the requirements for eligibility, a Sheriff, Under Sheriff or Deputy Sheriff that Transfers employment to Hamilton County, must have at least (10) years of continuous service with Hamilton County. If the retiree only has half of the (20) requirement or (10) years of Hamilton County Service, the retiree would be eligible for one half of the full benefit. If the retiree's Hamilton County Service is more than (10) years, but less than the full (20) years required, the retiree health insurance benefit would be prorated as follows: 10 years – 50% of full benefit, 11 years – 55% of full benefit, 12 years – 60% of full benefit, etc.; up to the standard benefit at (20) as normally offered.

**Eligibility – Correction Officers** – To be eligible for coverage, each of the following requirements must be met: a) have at least twenty (20) years of continuous

service with the County; b) retire directly from the County into the New York State Retirement System; c) employment was not terminated for cause; d) did not voluntarily terminate his or her employment with Hamilton County prior to obtaining 55 years of age as fixed by the New York State Retirement System. Correction Officer retiring at 55 years of age should know that they will be subject to a penalty with New York State Retirement.

# For all retirees, a retiree that meets the required criteria, who elects not to participate in the medical insurance plan made available to them by the County at the time of retirement, may elect to participate later by written request. Participation is required to be during an open enrollment period or due to an eligible qualifying event. These eligibility requirements are subject to change by resolution of the Board of Supervisors.

Other Reports:

Mr. Tomlinson: He knows that they have discussed a County Manager in the past, but he thinks they need to do it as soon as possible when they are back after the new year. He would like to open discussions. He thinks that Mr. Farber has gone above and beyond for years. He has picked up the slack in many areas. After having a meeting this morning just seeing the things that he has done going above and beyond, it is not fair to the Chairman and in the future moving forward. The work needs to be done but they need somebody to do it. He stated that he wasn't underestimating what the Clerk of the Board does or downplaying it. They appreciate what she does but it's not her job either. He really thinks that they need to start thinking about hiring a County Manager and figuring out a way to move forward to do it. Mr. Arsenault stated that they are one of the few counties that don't have one. Also, like he had said in that brief meeting this morning, there is nobody that is going to spend the kind of time that Mr. Farber spent in that Chairman seat. It's not humanly possible and he is not sure how he did it. Mr. Farber stated that he shouldn't have done it if they wanted the truth. Mr. Arsenault stated that Mr. Farber was here day in and day out every day of the week and it's not feasible for the Chairman to do that. They all have their towns to run, and he truly thinks it does make sense to start looking down that avenue of a County Manager as well. He thinks it's going to help the Chairman and the County. It is not going to come cheap. Mr. Farber stated that if they look back in the record there has been extensive conversations in 1997 about the same subject. He had been told that just before he came on the Board from John Heffernan that several Supervisors had approached him with a similar conversation when he was getting ready to retire as County Treasurer with the idea of creating an Administrator position and having him do that job. It is not a new subject. There is a lot. He often talks about Hamilton County being a \$25Million plus a year business but they are not even as simple in some ways as a business. They have very complex responsibilities from Mental Health to DSS to Public Health Nursing and operating the CHHA. Mr. Tomlinson thanked Mr. Farber for the time he put in. They decided to have a meeting. Mr. Arsenault stated that when they had discussed this prior, he had reached out to other counties and had taken some notes down. He will look to see if he can find those. He thinks they all should make some phone calls and talk to other counties. The Chairman stated that Hamilton County is unique and thinks it is up to them to develop it the way they want it. Ms. Hunt reminded them that NYSAC is a big help in that regard.

Ms. Bain: Thank you again to Mr. Farber. Welcome aboard Butch Fernandez and she looks forward to working with him.

As there was no further business, motion to adjourn by Mr. Arsenault, seconded by Mr. Tomlinson. Carried.
