If equipment offered differs from the provisions contained in this specification, such differences must be explained in detail and bid will receive careful consideration if such deviations do not depart from the intent of this specification and are in the best interests of the County DPW as interpreted by the County Highway Superintendent.

PRICE: Price quoted shall be net and shall include delivery of new equipment, all transportation and delivery charges prepaid to the points of delivery fully equipped as specified.

TAXES: Purchases by the County of Hamilton are not subject to any sales or Federal excise taxes. Exemption certificates are not required for municipalities. The County of Hamilton is also exempt from the transportation tax and no exemption certificates are required for this tax. There is no exemption, however, for Social Security, Unemployment Insurance, and like taxes.

EXTENSIONS: As per New York State General Municipal Law, all political subdivisions are allowed to make purchases through this contract and the terms of this contract shall be extended to all the Municipal Subdivisions of New York State while it is in effect with Hamilton County. Upon cancellation by either party in writing, the contract is likewise no longer valid with the municipal subdivisions.
